International HQ: Budapest, Hungary - a non-governmental international organisation and the official international association of private security, founded on 7<sup>th</sup> April, 1994 in Hungary and registered in France and in the USA - represented by Prof. George POPPER, President and Founder

Both organisations set high value on the activities performed by the other party during the years. With the intention of making their future activities more effective and successful both parties agreed to a mutually close cooperation in the area of Sports and Security.

- ❖ regularly inform about the IBSSA activities and events on the UWMAF Homepage and via e-mail to its members, and also its regular and occasional newsletters / brochures

**The IBSSA undertakes to:**

- ❖ offer moral and participation, support and joint professional assistance to the events organised by the UWMAF
- ❖ regularly inform about the UWMAF activities and events on the IBSSA Homepage and its regular and occasional newsletters issued worldwide
- ❖ mobilise the rescue units linked to the IBSSA when needed - upon request of the UWMAF - in accordance with its possibilities
- ❖ joint collaboration between the IBSSA International Sport Federation (ISF) and UWMAF in technical, event and other areas of mutual interest

Both organisations with the aim of the smooth and effective cooperation under the above agreement consider the other party as collaborating partner.

IBSSA offers to promote the UWMAF, and UWMAF shall done the same, as its associated organisation by representing each other in regions where each organisation is present. The representatives will be entitled to participate in all official events of the IBSSA and so too will IBSSA in all UWMAF events.

Both organisations will have the right - on mutual understanding - to report their activities to their respective members.

The highest-ranking leaders of IBSSA will operate according to the accepted international rules of protocol and its statutes, and so will the UWMAF leaders according to its rules and regulations and its constitution.


Both organisations will remain independent.
