

Dear IBSSA Members,

we wish to inform you that distribution of the new IBSSA ID-cards for the year 2018 has already begun, so we invite all members of the association to pay the yearly membership fees!

**Please note that the membership fees have CHANGED!**

According to the rules of "Membership Dues and Method of Payment" everybody shall pay the Annual Dues without further notice not later than 31<sup>st</sup> of January of the annual year!

### *NEW Membership Dues for Individual and Corporate members*

#### **Individual Membership**

Annual Individual Membership Dues:	<b>250.- EUR / person / year</b>
One-time registration fee for newly joining members:	<b>50.- EUR</b>

#### **Corporate Membership**

Annual Corporate Membership Dues:	<b>2500.- EUR / corporation / year</b>
One-time registration fee for newly joining companies:	<b>200.- EUR</b>

#### **Terms of payment:**

Membership fee payment concerns the calendar year.

The term of membership begins at 1<sup>st</sup> of January of annual year and terminates at next year 31<sup>st</sup> of January.

If you have not paid your membership fee yet, please transfer the amount to the IBSSA Bank Account (*see below*), or you can also pay it in cash personally at the Headquarters (*Goldmark Károly street 35., Budapest, 1122 Hungary*).

Prof. George Popper – President of IBSSA urges all members of the Association to fulfil their obligation of paying the membership fee as soon as possible!

In the name of the IBSSA Board of Directors hereby we inform you about the followings:

- Annual membership fees have remained unchanged for over 20 years, while due to inflation and constantly higher prices the costs have increased significantly

In this way, it has become necessary to increase the membership fees.

However, not only this has changed, but from the year 2018 onwards – regarding the Cooperation Agreement with MEDIHELP International – **for each paid membership fee, the IBSSA members receive 1 NESACARD for one person, valid for one year.**

From a certain part of the new, increased membership fee, IBSSA assists the NESA organization for International Cancer Fighting and, as part of the co-operation, IBSSA members receive a NESA insurance card that includes many advantages when it comes to cancer.

Anyone who is not entitled to receive the card due to having such illness, in this case, the NESAs card can of course be rewritten to a family member.

After the IBSSA membership fee has been paid, the LAMP Services Ltd. insurance company – according to the information received from the IBSSA Headquarters – will contact you personally to match all data for the NESAs insurance card.
