## MINUTES

### Meeting of the Executive Committee (Comite Directors)

**Hotel Elizabeth/Singapore 19.12.1994  
10.00 a.m.**

H.R.H. Prince Adan Czartoryski Borbon, the President of "IBSSA" was welcoming the present Board Members and opened the meeting.

During the meeting some other Board Members were contacted by phone as form of telephone conference.

During the meeting the followings were discussed and decisions were taken:

1. The President gave general information about the international situation and the development of the international federation. (34 members representing 19 countries from 5 continents.)

2. The General Secretary gave information about the training program and distributed the material. It was agreed that the next Bodyguard Training Camp will be organized at the last 2 weeks of February 1995 in France. Participation only for IBSSA members is allowed. Participation fee: FF 16.500.- which includes 2 week accommodation, food and the whole training program with examination. An information will be sent to all members before January 1995.

3. The Treasurer gave information on financial situation. He explained that he proposes that IBSSA should not raise the membership fee, but to have more incomes from advertisements and security exhibitions. He also reported that all the new members paid their registration and membership fees.

4. Mr. Popper reported that the bank accounts for IBSSA were opened in Vienna and Budapest.

5. It was decided, that the new Danish member, Mr. Henrik Brandt will be the Coordinating President for Scandinavian countries and he will be also in charge for public relations and publications. His first task will be to issue a printed information bulletin about IBSSA. Deadline 31.March.1995.

6. The General Secretary informed the meeting about new applications for membership. He also announced that all necessary conditions were controlled and so he proposed to accept the membership of the following individuals or companies:
