The following subjects were discussed during a meeting with His Excellency George Popper – Executive President of IBSSA

- IBSSA in Slovakia

Mr. Richter reported, that Slovakian members had a meeting 2 months ago and soon they will have another one. They decided to form IBSSA-Slovakia officially.

The Executive President informed that Slovakian members have full rights and freedom to decide in which form IBSSA -Slovakia will be operating or registered and what leadership they elect.

- New Training School

The Slovakian delegation announced, that they opened a Training School in MARTIN and wish to operate it under IBSSA recognition.

The subject was discussed, contacts with Mr. Miki VARGA – a member of the Education and Qualification Department were established.

- Bodyguard World Championships

Mr. Richter reported, that a year ago, when the preparations started, he visited Zlin where he had a very successful meeting with Mr. Alexandr CACH – President of the Preparatory Committee. During the last few months there was a lack of information. The problem is that weather conditions in Zlin are not the best to organize the event in WINTER-time. After a long discussion the following proposal was the outcome:

- Spring 2001 (April – May)

The first IBSSA BODYGUARD DEMONSTRATION WORLD CHAMPIONSHIP should be organized in Zlin / Czech Republic. National or Company teams must prepare Bodyguard Situation Demonstrations. An International Jury will decide which would be the best.

- November 2001

The first IBSSA Bodyguard World Championships should be organized in Israel, hosted by the “Israeli College for Security and Investigation”.

Concerning this proposal the General Secretary, Mr. Rony KLUGER was contacted by phone and he agreed. If other Board members will agree then next week the subject must be discussed with Mr. Cach. The Slovakian IBSSA members promised full support and active contributions for the preparatory work.

After the meeting the Delegation and the Executive President visited “IN-KAL” Security Co., one of the leading and most successful security companies of Hungary.

Mr. György LASZ – former spokesman of the Hungarian Police and advisor of the Minister is the owner of the company. In his welcome speech he introduced „IN-KAL”. They are the leading company in the field of security at sport, cultural and other

events. With about 500 organizers they give security services of events up to 300.000 – 500.000 participants. (Pepsi-island, festivals, concerts, football matches, etc.)

IN-KAL Security also guards about 200 objects, buildings in Hungary, active in Money and Value transportation, as well in Private Investigation.

The Delegation visited the offices, the surveillance center and the “Museum of Hooliganism”. Over 2000 articles, which were confiscated at the security check at Football matches, concerts, etc. (Knives, chains, bombs, hammers, sticks, maces, hatchets, battle -axes, bottles, etc.)

The Museum in the future will have different parts:

- Museum of Hooliganism
- Police Museum
- IN-KAL Museum

Mr. Lasz offered, that he is ready to ensure a room for IBSSA Museum.

As closing the official program, Mr. Miki Varga – member of the E&Q Department offered a dinner in a Medieval Restaurant with the presence of Mr. Alexander Hevesi – General Secretary of IBSSA Austria. They reported, that a very successful examination of a Bodyguard Training Course was just finished. During the dinner, cooperation among Slovakia-Hungary-Austria, on the field of education, training and championships, was agreed.
