IBSSA – International Bodyguard & Security Services Association

The official international association of private security, manpower and technical resources, technological companies and individual members of the profession.

The IBSSA is a nonprofit international association involved in organizing, coordinating, giving assistance, technical help and development to its members worldwide in the field of security in all its forms.

The association was registered in France in 1994. The Honorary Founding President of the IBSSA is H.R.H. Prince Adan CZARTORYSKI BORBON. The IBSSA has today over 1200 members from more than 80 countries, 70-80% of the members represent different security companies or organizations.

The information services of IBSSA:

The IBSSA publishes a biannual booklet listing its Member corporations, Individuals, Instructors and Bodyguards with their specialty expertise, the languages they speak, etc. In all issues members are offered special services as well as reduced prices in various fields.

The IBSSA circulates its members with all technical news and personal information concerning security, bodyguards and their work. The IBSSA offers the services and possible partnership of its members to a worldwide audience.

The IBSSA holds a Congress each year. During the Congress a security exhibition is organized. Members shall enjoy a 20% reduction of exhibition prices. Members have the right to introduce their activities and products during the Congress or other such events.

The IBSSA Training Program:

The main training centers are located in Switzerland, Israel, Romania, Latvia, France and Hungary. The training centers recognized by the IBSSA incorporate the expertise of international instructors such as the French Presidential Guard and other global specialists.

Training seminars last from 2 weeks to 3 months. There are basic and advanced courses as well as general and special thematic such as shooting, self-defense, martial arts, specialist driving, close contact, bodyguard, etc. Group training is based on a 10 person minimum and 15 person maximum attendance. Training sessions are always available. After every training course, an internationally recognized diploma and identity card with photograph of the participant will be issued, and their name included on the IBSSA list of recognized bodyguards. Security guards, bodyguards and other experts or instructors are entitled to carry an IBSSA passport also. It is available from any IBSSA Regional or Country Representative.

Based on the same program (thematic) there are training camps organized in Switzerland, Romania, Russia, Great Britain, Florida, Ivory Coast, South Africa and Hungary, or in the case of a demand in any other country. The member country organizing the training camp is fully responsible and will ensure all necessary insurance is provided for the members.

The IBSSA has its own international organizing committee, which is a well trained team with vast of experience in organizing cultural, sport, business events and conferences. It has worldwide representation with special security conditions and protocol services. The IBSSA international organizing team may be hired or contracted.

Membership and Registration fees for Corporate and Individual members

IBSSA Membership for Corporate:

The President or General Manager of the company has to sign a "Letter of Intent" or an "Application for Membership", which has to be written in one of the official languages of the Association English or French. A short summary of the company and a copy of the official registration of the company should be enclosed. You should nominate 1 to 12 persons of the company whom you wish to be supplied with the international ID and 2 photos of these persons are required, any further person shall only pay 100.- US\$ plus one time registration fee 25.- US\$. The application form is enclosed, that everyone has to complete and send to the Headquarters. The last step is transferring the fee to the IBSSA account.
 The registration fee for company: 200.- US\$
 The annual membership fee: 2000.- US\$

IBSSA Membership for Individuals:

Applicant should send the enclosed application form to the headquarters or any IBSSA representative. Bodyguards should enclose a photocopy of their international or national bodyguard license or any previous education. Everyone has to send a short CV and color photo of himself.
 The registration fee for individual: 50 US\$
 The annual membership fee: 200 US\$
 After IBSSA receives all necessary documentation and fees it takes about a month to process the application and another month to receive the agreement of the Board on the membership

Membership and Registration fees for Supporting members

IBSSA Membership for Supporting Corporate:

The president or General Manager of the company has to sign a "Letter of Intent" or an "Application for Membership", which has to be written in one of the official languages of the Association English or French. You should nominate 1 to 12 persons of the company whom you wish to be supplied with the international ID and 2 photos of these persons are required.  The annual membership fee: 1000.- US\$

IBSSA Membership for Supporting Individuals:

Applicant should send the enclosed application form to the headquarters or any IBSSA representative. Bodyguards should enclose a photocopy of their international or national bodyguard license or any previous education.

Everyone has to send a short CV and color photo of himself.

The registration fee for individual: 50 US\$

The annual membership fee: 100 US\$

After IBSSA receives all necessary documentation and fees it takes about a month to process the application and another month to receive the agreement of the Board on the membership

Supporting Membership is for corporate and individuals they are not directly involved in the security profession. They pay full registration fee but only 50% of membership fee. These will members receive all publications, documents, ID-s. These members have the right to participate at all events, but *they have no voting right at the Congress.*

Associated Membership

The associated membership is open for other organizations based on bilateral agreements.

Patronizing Corporation and Patronizing Individual Membership

The Patronizing Corporation and Patronizing Individual Membership is open for organizations and Individuals based on bilateral agreements.

Terms and Conditions of paying the annual membership and other fees:

Everybody shall pay the membership fee without further notice not later than 31st of January of the annual year!

Distribution of annual membership cards begins at 1st of January of annual year if payment was received by the IBSSA, therefore it is highly recommended to pay the membership fee prior to that date!

Late payments will result in surcharge.

Payment received after January 31 but not later than 31st of March shall pay 10% surcharge.

Payment received after 31st of March shall pay 20% surcharge.

The IBSSA will invoice of each payment upon request only. Invoice will be addressed to the Corporate or Individual data as is registered at the IBSSA.

Non-regular payment of membership fee will result in exclusion of membership, cancellation of positions and IBSSA recognition if any. These members are not entitled to benefit of any of IBSSA related services, use of IBSSA Logo or Trademark or any IBSSA references. Members will be excluded of the list of members without further notice after 2-year nonpayment of membership fee.

According to former decisions, all members holding any IBSSA position should pay membership fee in advance for a five-year period of time. These members shall transfer 600 US\$ membership fee instead of 1000 US\$.

Regular Corporate or Individual, Supporting or Patronizing members can also pay 5-year membership fee in advance in order to receive 40% reduction of membership fee.

Replacement of lost IBSSA ID (card and holder) costs: 50-US\$

Terms of payment:

Membership fee payment concerns the calendar year.

The term of membership begins at 1st of January of annual year and terminates at next year 31st of January.

New applications received in 3rd or 4th quarter of the annual year but not later than 31st of October shall only pay 50% of membership fee plus the whole amount of registration fee.

New applications received after 31st of October but not later than 31st of December shall pay the full membership and registration fee but the membership is current for the forthcoming year!
